1. Introduction

1.1 Product overview

EPOS Manager is a cloud-based or on-premises multi-tenant server application used for managing and supporting EPOS devices in Enterprise environments.

Companies signing up for a tenant (company) account will gain access to an easy to manage system, from where enrolled EPOS Connect clients (End-users) in the organization can be managed.

The IT administrator can easily track EPOS devices in the environment from any machine, push configurations and quickly deploy software and firmware updates to a vast number of end-users.

EPOS Manager: Administering devices, end-users and associated client application.

EPOS Connect: End-user client application, providing local update, configuration and support for interface with a range of softphones via the embedded drivers for connected devices.

1.2 Attributes of EPOS Manager

EPOS Manager enables a tenant administrator in an organization to:

- Manage assets by providing full status overview
- Locate devices and fetch device details from anywhere.
- Identify devices in the organization having an outdated version of firmware
- Accomplish uniform attributes throughout the environment by deploying firmware/ software updates
- Read and set settings on EPOS audio devices from anywhere.
- Identify underutilized devices to fully use the inventory, hence optimizing the benefit of the device investment.

1.3 Scope of the document


This document contains an overview of EPOS Manager features and how to perform tenant administrative tasks using the EPOS Manager.

1.4 Intended audience of this document

This document is intended for the selected Tenant Administrator. The tenant administrator will be able to manage deployed EPOS devices.

1.5 EPOS Manager Workflow

The following diagram shows the basic workflow of the EPOS Manager (used by Tenant Administrator) and EPOS Connect (used by end-users) applications.



2. System Requirement

2.1 Overview of system requirement

Administrators can manage several phases of firmware or software deployment, including preparation, distribution and upgrades in different phases, depending on their infrastructure and requirements:

- SQL server and EPOS Manager hosted on the same machine
- SQL server deployed on one system, EPOS Manager hosted on another system
- If server is installed as a virtual machine, then nested virtualization needs to be enabled for servers running the Hyper-V, VMWare or any other virtualization host.

2.2 Hardware requirement

The following hardware is required for the EPOS Manager to install and run successfully on a system:

- Processor: 2 GHz processor
- RAM: 16 GB RAM (recommended) 8 GB RAM (minimum)
- Storage: 50 GB available
- Network card (Gigabit (10/100/1000baseT) Ethernet adapter)
- Desired Configuration: RAID 1 (recommend for SQL server)

2.3 Software requirement

The following minimal software is required for the EPOS Manager to install and run successfully on a system:

- Supported Database Edition: SQL 2017 Standard/Express Edition 64 bit or higher / Azure SQL
- Docker Desktop version 3.1 or later
- Docker Engine version 20.10.12 or later
- PowerShell version 5.0 or later version

2.3.1 Installing Docker Desktop/Docker Engine

Linux Docker hosting environment is required for EPOS Manager. You can install the Docker Desktop with WSL 2 backend software on Windows by following the instructions here https://docs.docker.com/docker-for-windows/install/

Note: Docker has updated its terms and conditions and it requires a paid subscription. For more details https://www.docker.com/blog/updating-product-subscriptions/

Installing Docker Engine

Linux Docker hosting environment is required for EPOS Manager. You can install the Docker Engine with WSL 2 backend software on Windows.

To install the Docker Engine, follow the below instructions.

WSL 2 Backend

Open powershell with admin rights and execute the following command

wsl --install

This command will enable the required optional components, download the latest Linux kernel, set WSL 2 as your default, and install a Linux distribution for you (Ubuntu by default) If your current setup does not have Ubuntu as default, then use this command

```
wsl --install -d Ubuntu
```

It will most likely require a restart, and start up with Ubuntu where you will be prompted with adding a username and root password. Notice, that sudo command is a way of executing commands as admin.

WSL 2

We need to make sure we run WSL 2 instead of WSL. Open Powershell with admin rights. List the distributions running in WSL / WSL2.

```
wsl --list -v
```

This will give a list of distributions installed and running. Below you can see an example of a distribution NOT running WSL2, and this needs to be upgraded. If all is running WSL2 there is no need for upgrading.

```
PS C:\Users\M1034661> wsl --list -v
NAME STATE VERSION

* docker-desktop-data Running 2
docker-desktop Running 2
Ubuntu-20.04 Running 1
```

In Powershell run the following command

```
wsl --set-default-version <distribution-name> <wsl-version>
```

i.e.

```
wsl --set-default-version Ubuntu-20.04 2
```

```

Ubuntu command window

Open ubuntu and navigate to mounted drives (your c drive i.e.)

```
dpbs@A2ML29073:/mnt/c
dpbs@A2ML29073:~$ cd ..
dpbs@A2ML29073:/home$ cd ..
dpbs@A2ML29073:/$ cd mnt
dpbs@A2ML29073:/mnt$ cd c

Docker Setup

Run the following commands on Ubuntu (20.04) to setup Docker Engine on your machine.

Note: You will often need to answer Y to proceed installing and updating, and you will need to provide password to execute the commands.

Update and upgrade your Ubuntu distribution.

```
sudo apt update
sudo apt upgrade
```

Start installing Docker, Refer to https://docs.docker.com/engine/install/ubuntu/ for more details.

```
sudo apt-get update
```

```
sudo apt-get install \
  apt-transport-https \
  ca-certificates \
  curl \
  gnupg \
  lsb-release
```

```
curl -fsSL https://download.docker.com/linux/ubuntu/gpg | sudo gpg --dearmor -o
/usr/share/keyrings/docker-archive-keyring.gpg
```

```
echo \
  "deb [arch=amd64 signed-by=/usr/share/keyrings/docker-archive-keyring.gpg]
https://download.docker.com/linux/ubuntu \
  $(lsb_release -cs) stable" | sudo tee /etc/apt/sources.list.d/docker.list >
/dev/null
sudo apt-get update
sudo apt-get install docker-ce docker-ce-cli containerd.io
sudo apt install docker-compose
sudo service docker start
sudo groupadd docker
sudo usermod -aG docker $USER
newgrp docker

At this point you should have a fully operation Docker Engine installed running on Ubuntu under WSL2. You can check this by trying to run the hello-world image from Docker Hub.

```
docker run hello-world
```

One drawback of this approach is that you will need to start the docker service yourself after rebooting or restarting WSL2. You can do this by running the following command.

```
sudo service docker start
```

For making sure Docker is started every time we open the Ubuntu command window, we need to run the necessary commands in your user startup scripts (.profile). Do it with a check to see if the service is running first, like:

sudo service docker status || sudo service docker start

2.4 Operating system requirement

The desired operating system for EPOS Manager is Windows Server 2019 with Virtualization enabled, 64 Bit or higher.

EPOS Manager supports Windows Server 2016 (Updated Feb 2018).

Docker Engine supports Windows Server 2019 or higher.

Configuring EPOS Manager with Docker on Windows Server 2016 requires the following setup

Note: 16GB RAM is required.


- 1. Install "Windows Server 2016 (Updated Feb 2018)"
- 2. Install Docker Desktop ver 2.0.0 community edition https://download.docker.com/win/stable/31259/Docker for Windows Installer.exe

When prompted for Containerization and Hyper-V, click yes.

3. Installing EPOS Manager

3.1 Prerequisites

The customer has to login to EPOS Manager at https://enterprise.eposaudio.com by providing cloud Tenant login credentials.



Navigate to Manage Updates layout using "Manage Updates" menu. To download EPOS Manager,

Go to the tab "Software Updates". Locate release to be downloaded and click the download icon in the 'Action' column.

Once downloaded, extract the package and it contains files required for the installation of EPOS Manager.

The following files should be available:

- ChangeDefaultPartner.ps1
- GetResetPasswordURL.ps1
- MigrateLocalFolders.ps1
- docker-compose-https.yml
- docker-compose-http.yml
- .env

3.2 Installation steps

3.2.1 SQL Permissions

EPOS Manager uses 3 databases to manage its applications – Web API, Identity, Tenant (Organizations can provide any name for these databases and map these names in the .env file)

EPOS Manager requires that the SQL user provided as part of the .env file has a minimum permission of db_owner. If the SQL user provided has db_creator access, these databases would be auto created as part of the installation during docker-compose up. Alternatively, organizations can create these databases upfront and only provide the db_owner access to the SQL user configured.

It is recommended that the below size is allocated for each database at the minimum:

- Web API 5 GB
- Identity 1 GB
- Tenant 1 GB

3.2.2 Configuring .env file

EPOS Manager installation can be configured on multiple parameters. The subsequent sections explain on how the configuration is done in the environment file (.env) available in the downloaded package. Open the .env in notepad or a suitable editor and the file should be in the same folder level of the docker-compose files

3.2.2.1 Configuring databases

Identity_ConnectionString - to specify the Identity Database connection string in .env file

UCMP_ConnectionString - to specify the Tenant Database connection string in .env file

WebTool_ConnectionString - to specify the Web API Database connection string in .env file

If SQL server is running on same server (host.docker.internal alias for local server ip) the below configuration should be done depending on the type of authentication:

SQL Authentication: "Server=host.docker.internal,1433;Database=< dbname >;uid=< user >;-password=< pwd >;"

Windows Authentication: "Server=host.docker.internal,1433;Database=< dbname >;Integrated Security=True;"

If SQL server is running on a different server specify the IP/hostname of the server depending on the type of authentication:

SQL Authentication: "Server=<IP/hostname>,1433;Database=< dbname >;uid=< user >;password=< pwd >;"

Windows Authentication: "Server= <IP/hostname> ,1433;Database= < dbname > ;Integrated Security=True;"

Note: 1433 is the default port of the SQL server. If SQL server is configured to run on a different port need to specify the same port here. To find which port SQL server is running on you could run the following command in the master database of the SQL server

xp_readerrorlog 0, 1, N'Server is listening on'

If SQL Server is Azure SQL:

ConnectionString: "Server=< Azure SQL DB Server name >;Database=< dbname >;uid=< user >;password=< pwd >;"

3.2.2.2 Configuring local storage URL

LocalStorageUrl – this to specify the location where the FW/SW updates will be stored and shared with the EPOS Connect clients.

The storage should be on the same machine where the Docker Desktop/Docker Engine is installed. As this URL should be accessible by EPOS Connect clients it is recommended that you use an ip-address/hostname/cname. The default value provided in .env file is http://localhost:10000/devstoreaccount1

Admin can change the protocol, port, and server name in the LocalStorageUrl.

Note: Port configured in the LocalStorageUrl should be opened through firewall. Changing the port and protocol would require updating the docker-compose files as described in section 3.2.3.

3.2.2.3 Configuring CName

CName – this is to specify the CName by which EPOS Manager is accessible within the organization.

Default value for CName would be localhost, if the organization has a valid certificate and domain name then that domain URL could be provided in the CName.

If domain name is not available, it is recommended to provide the hostname / IP address.

3.2.2.4 Configuring Certificate

EPOS Manager can be configured to use secure communication protocol. This requires the admin to provide the certificate to be used for secure communication and its password. This is covered in section 3.2.3.2.1.

3.2.3 Configuring custom ports and secure protocol for EPOS Manager

Configuring the ports is done through the docker-compose file. Docker compose is a tool for defining and running multi-container docker applications. With docker compose, you use a YML file to configure your application's services. Then, with a single command, you create and start all the services from your configuration.

In the docker-compose file, the exposed ports are mapped to the internal ports. Inside docker, the services can communicate by simply specifying URLs as http://< servicename >. To access the service from outside the docker instance, it must be exposed through one or more ports.

The downloaded package contains 2 docker compose files:

- docker-compose-http
- docker-compose-https

3.2.3.1 Configuring EPOS Manager for HTTP

docker-compose-http is configured by default to run EPOS Manager in http and the following ports are used for each of the microservice / functions.

Site Name	Port Number
epos_manager_ui	80

If any of the ports needs to be customized, then the following sections of the docker-compose-http.yml file should be modified accordingly.

Note: HTTP ports configured in the docker-compose-http file should be opened through firewall.

3.2.3.2 Configuring EPOS Manager for HTTPS

SSL (Secure Sockets Layer) certificates are an integral part of securing the sensitive information sent across the internet. Information is encrypted to block any unintended access.

For a more secure connection, the tenant may edit port or configure protocol to HTTPS for all websites as follows

docker-compose-https is configured by default to run in https and the following ports are used for each of the micro service / functions.

Site Name	Port Number
epos_manager_ui	44308

Note: HTTPS ports configured in the docker-compose-https file should be opened through firewall.

3.2.3.2.1 Configuring SSL certificate to be used for HTTPS communication

A SSL certificate is required if EPOS Manager needs to be configured for HTTPS communication. Organizations can use existing domain certificates or procure a new one. The certificate should be placed in a folder named "Certs" which must be at the same level as the docker-compose-https.yml file.

Place the Personal Information Exchange (.pfx) file inside the Certs folder. If the certificate is protected with a passphrase, then this needs to be set as well. Following certificate details has to be added as part of the .env file

- CertificatePath /root/ucmpcerts/<certificate_filename>.pfx
- CertificatePassword <certificate_password>

3.2.4 Hosting the EPOS Manager (On-Premises) Server

To host the EPOS Manager (On-Premises) server open powershell and navigate to the folder where the docker compose files are available and then execute the following command

Starting EPOS Manager

- For HTTP: docker-compose -f docker-compose-http.yml up
- For HTTPS: docker-compose -f docker-compose-https.yml up

The script will pull the docker container images of EPOS Manager from Docker Hub (https://hub.docker.com/) and start the docker instance.

Stopping EPOS Manager

- For HTTP: docker-compose -f docker-compose-http.yml down
- For HTTPS: docker-compose -f docker-compose-https.yml down

The script will stop the docker instance of EPOS Manager.

3.3 Upgrade from EPOS Manager v5.x.x (Exe installers) to v6.1.0 and higher

EPOS Manager v5.0.0 - v6.0.0 is based on Wix installers. EPOS Manager latest versions are based on docker and need to follow the below steps for upgrade.

3.3.1 Configuring .env file

Follow the steps as described in section 3.2.2 for configuring the .env file. The below database names should be used in the connection string so that the same database is referred.

- Identity_ConnectionString SennComm_Identity
- UCMP_ConnectionString SennComm_Ucmp
- WebTool_ConnectionString Database name configured during the installation of previous EPOS Manager.

3.3.2 Configuring custom ports and secure protocol for EPOS Manager

Follow the steps described in section 3.2.3. If HTTP is used in previous installation and no ports are changed then the default docker-compose-http.yml can be used without any changes.

3.3.3 Uninstalling EPOS Manager (older version)

To Uninstall EPOS Manager from the system, follow the steps below:

- Step 1: Open Control Panel.
- Step 2: Select Programs.
- Step 3: Click Uninstall a Program from Programs and Features.

Locate the following two files to successfully uninstall the application:

- EPOS Manager.
- EPOS Manager API.

Note: When uninstalling the application always uninstall EPOS Manager and then uninstall EPOS Manager API.

3.3.3.1 Uninstall EPOS Manager

To uninstall EPOS Manager from the system, follow the steps sequentially.

Right click on the "Installed EPOS Manager" and select "Uninstall". In the Programs and Features dialogue box click "Yes". Click "OK" in the "Uninstall EPOS Manager" UI box. A progress bar will track the uninstalling of the application.

3.3.3.2 Uninstall EPOS Manager API

To uninstall EPOS Manager API from the system, follow the steps below:

Right click on the Installed EPOS Manager API and select "Uninstall". In the Programs and Features dialogue box click "Yes". A progress bar will track the uninstalling of the application.

Note: Do not delete manually any folders in the below location until the migration is complete.

[IISInstalledDrive]\inetpub\wwwroot

3.3.4 Hosting the EPOS Manager (On-Premises) Server

Follow the steps described in section 3.2.4.

Note: If there are any changes done to the ports or protocol of epos_manager_webapi from the previous version, download the latest tenantconfiguration.dat from EPOS Manager UI and circulate to all users.

3.3.5 Migrating firmware/software files from WIX to Docker

After hosting EPOS Manager, the firmware / software updates uploaded in the previous version need to be migrated to the new system.

As part of the downloaded package MigrateLocalFolders.ps1 script will be available. Run the MigrateLocalFolders.ps1 file using the below command and the files will be copied to the Azure storage

\MigrateLocalFolders.ps1 -FirmwareUpdatesFolderPath "C:\inetpub\wwwroot\UpdateAPI\ FirmwareUpdates" \

- StandAloneVPsFolderPath "C:\inetpub\wwwroot\UpdateAPI\StandAloneVPs"
- AzuriteUrl http://:10000

Note: The default location of IIS is in root of C:\ drive, but if not, please adjust folder paths accordingly.

AzuriteUrl should be updated to the one configured in Section 3.3.1.

3.4 Upgrading to future EPOS Manager versions

Download the EPOS Manager package from the cloud.

Navigate to the folder where the existing EPOS Manager docker instance is running.

Stop the existing instance using the below command:

- For HTTP: docker-compose -f docker-compose-http.yml down
- For HTTPS: docker-compose -f docker-compose-https.yml down

Configure the environment file and docker compose file from the new package.

Start the new EPOS Manager docker instance using the below command

- For HTTP: docker-compose -f docker-compose-http.yml up
- For HTTPS: docker-compose -f docker-compose-https.yml up

Note: If there are any changes done to the ports or protocol of epos_manager_webapi from the previous version, download the latest tenantconfiguration.dat from EPOS Manager UI and circulate to all users.


3.5 Offline installation

EPOS Manager docker instance can be installed offline using the below steps. The complete offline installation needs the images to be uploaded manually to a local Docker repository. When docker-compose file is pulling the images, it will find them locally and use those, and as such no need for an online connection to Docker Hub.

This needs to be done as below

- 1. Pull images to intermediate computer's local Docker repository
- 2. Save images from local Docker repository to movable file storage
- 3. Move images to offline server
- 4. Load images to offline servers Docker repository
- 5. Install EPOS Manager

Below diagram illustrates the flow from left to right



3.5.1 Download docker images

On an intermediate computer, Docker for Desktop/Docker Engine needs to be installed. Use the docker-compose files from the package to download the images to local docker repository.

You can use any of the below commands to pull the epos manager docker container images.

- docker-compose -f .\docker-compose-http.yml pull
- docker-compose -f .\docker-compose-https.yml pull

Note: Clean up all the existing images from Docker desktop/Docker Engine before pulling new images

3.5.2 Save images to local file storage

The images from a docker repo must be exported to .tar format. This needs to be done with exporting based on repo reference and tag, to preserve tags. This is important for docker compose, so there is no need to change the image references.

Open powershell and run the below command to generate the .tar file

docker images ' | ConvertFrom-String ' | select-skip 1 ' | ForEach-Object { ' docker save "(\$.P1) : \$ (\$.P2)"-o'"\$(\$.P1.Replace('eposaudio/',").Replace('mcr.microsoft.com/azure-storage/',")).tar" '}

Once this command is executed the .tar files will be available in the folder from where the command was run.

3.5.3 Move files to offline server

The .tar files and the EPOS Manager package downloaded needs to be moved to the offline server, by using an external hard drive or similar. The .tar files should be placed in the same folder as the docker-compose files of EPOS Manager.

3.5.4 Load images into offline Docker repository

When the exported images are moved to the offline server, the .tar files of the images needs to be uploaded into the local Docker repository.

Open powershell and navigate to the folder where the .tar files are available and run the following command to load the images

Get-ChildItem -Path .\ -Filter *.tar -Recurse -File ` | ForEach-Object { docker load --input \$_ }

3.5.5 Install EPOS Manager

Follow the installation steps from section 3.2 to do the installation of EPOS Manager.

4. Getting Started

4.1 Pre-Registration

Once you installed EPOS Manager On-premise, a default partner will be created automatically. It is recommended to change your default partner details after you install the On-premise solution first time as below steps. You can always use the partner details to reset your password.

Default Partner details:

- Partner Name: Default Partner

- Partnerld: 9E8F4402-943A-4D92-8DE2-D29615E68D0D

To change the default partner details, you can execute the poweshell script ChangeDefaultPartner.ps1 available in the downloaded package.

The script will ask for the below input parameters:

- Identityendpoint: The URL of epos_manager_identity. For example http://localhost:8081
- Partnerld: Current Partnerld. If it is the default one, refer to above details.
- PartnerKey: Current PartnerKey. If it is the default one, refer to above details.
- ParnerName: Tenant Admin to enter the new Partner name which you wish to put.
- Ucmpendpoint: The URL of epos_manager_api. For example http://localhost:8082

The output of the script will be the updated Partner name, PartnerId, PartnerKey. Please save these details as it is required to reset the password for Tenant Admin.

4.2 Registration

4.2.1 On Premises SignUp

You can sign up on EPOS Manager On-Premise Solution at http://< UI URL >/#/signup UI URL – the hostname/IP address of the system where the EPOS Manager is installed.

For the signing up in the network, following company information is required:

- Company Name
- Tenant Name
- Admin First Name
- Admin Last Name
- Admin Email ID
- Region
- Country
- Time Zone
- Enter Password
- Re-enter Password
- Show Password

Click Submit button to finish signing up in the on premise environment.

4.2.2 Logging in

Post registration, you can login by using your Email ID as the username and the password set during registration.

For connecting to EPOS Manager, following browsers are recommended:

- Google Chrome
- Microsoft Edge
- Internet Explorer (IE) 11
- Mozilla Firefox.

For connecting to EPOS Manager from a Mac OS, Safari browser is recommended.

Login to EPOS Manager at: http://< UI URL >

UI URL – the hostname/IP address of the system where the EPOS Manager is installed.

4.2.3 Forgot Password

In case the login password has been forgotten, Tenant Admin can use the powershell script GetResetPasswordURL.ps1, available in the downloaded package, to generate the reset password URL. A sub admin can alternatively request the Tenant Admin to generate the Reset Password URL from the Administration view.

The script will ask for the below input parameters:

- Identityendpoint: The URL of epos_manager_identity. For example http://local □ host:8081
- Partnerld: Current Partnerld. If it is the default one, refer to section 4.1 for details.
- PartnerKey: Current PartnerKey. If it is the default one, refer to section 4.1 for details.
- Ucmpendpoint: The URL of epos_manager_api. For example http://localhost:8082

- Email Id: Email address of the user for whom the password reset is required.
- The output of the script will be the Reset Password URL. Tenant Admin can copy this link to the browser and reset the password.

4.3 Deployment of the EPOS Connect

The end-user application EPOS Connect must be installed on end-user machines required to be managed via the EPOS Connect.

EPOS Connect supports the following variants:

- EPOS Connect for Win
- EPOS Connect for MAC
- EPOS Connect for VDI and thin clients

Clients can use any of these variants based on the organizations infrastructure.

4.3.1 Retrieving client files for the first time

Navigate to Manage Updates layout using "Manage Updates" menu. Go to the tab "Software Updates". In this view, you have the possibility of downloading the latest EPOS Connect client to your local machine by clicking the download icon.

Once package containing zip file is downloaded, please create a folder where you unpack the downloaded file. After unpacking the file, folder should now contain the following files for windows: (version number can vary)

- 1. EPOSConnect_4.0.0.9.exe
- 2. product details.txt
- 3. TenantConfiguration.dat
- 4. WebToolAgent.xml
- WebToolAgentReleaseNote.txt

EPOS Connect for Win latest version supports msi installer and can also be downloaded from the same view. It will contain the following files for Windows:

- 1. DSEASDK.msi
- 2. EPOSConnect_7.1.0.20448.msi
- 3. PackageInfo.xml
- 4. product details.txt
- 5. TenantConfiguration.dat
- 6. WebToolAgent.xml
- 7. WebToolAgentReleaseNote.txt

Both msi need to be installed on the machine. EPOS Connect msi needs to be installed for firmware updates and device configuration. DSEA SDK msi needs to be installed for call control support. The sequence of installation is EPOS Connect MSI followed by DSEA SDK MSI. The custom MSI parameter 'AUTOLAUNCH_ENABLED=0' has to be set for the DSEA SDK MSI installation.

EPOS Connect for MAC installer can be downloaded following the same steps as for EPOS Connect for Win.

4.3.2 Installing the client manually for the first time

From the installation folder containing the installation files and the TenantConfiguration.dat file, run the exe/pkg file. (Administration rights to the machine are required.)

Follow the guide and complete installation.

Start the application by clicking the EPOS Connect shortcut on the desktop – or find it by typing EPOS Connect in the search program under the Windows menu. On MAC you can start the application by typing EPOS Connect in the AppFinder and launching it.

Please leave time for the product to initialize and negotiate with the cloud service. Usually it takes a few minutes, but in a few cases it can take up to 5 minutes.

Log in to your web portal and click on the Manage User menu item. Your user automatically gets added to the system after the negotiation has taken place.

Mass Deployment

The ability to distribute software to a number of users or computers from a centralized location has become a requirement for many administrators.

The software is installed without the administrator physically visiting each machine. An administrator can use system management software to control a user's environment.

EPOS Connect installation supports silent installation and uninstallation.

Windows:

The command line arguments used for the silent installation of the EPOS Connect application installer is: EPOSConnect_x.x.x.xxxxx.exe /S /v/qn

For silent uninstallation of the EPOS Connect, run command from the location of installer file: EPOSConnect x.x.x.xxxxx.exe -silent –uninstall

For silent uninstallation of SDK, run command in admin mode from the location of installer file: wmic product where name="DSEA SDK" call uninstall /nointeractive

Note: The silent installation does not trigger the application to start, so a restart of the PC is required to start up application. If an administrator wishes to start the application after silent installation he should launch the below exe after installation.

32 bit OS: C:\Program Files\EPOS\EPOS Connect\ECLaunch.exe 64 bit OS: C:\Program Files (x86)\EPOS\EPOS Connect\ECLaunch.exe

MAC:

The command line arguments used for silent installation of the EPOS Connect: installer -pkg EPOSConnect.pkg -target /

For silent removal of EPOS Connect Application it is recommend that you use the uninstall script as part of EPOS Connect Application. Open the terminal and run the below command:

/Library/Application Support/EPOS/EPOS Connect/uninstall.sh

Product Code (Windows Only)

The Product details.txt files contain the Product Code. This is used for detection validation.

4.4 EPOS Manager Layout

The layout of EPOS Manager is divided into sections as described below.

4.4.1 Login information

The login information will give the administrator access to settings, download the account unique "TenantConfiguration.dat" file, change credentials and terminate the current session.

In the dropdown menu, select the option that corresponds to the required function to be performed.

Please note that changes made in settings will be applicable for all users

4.4.1.1 Settings (General & Data privacy)

System settings are displayed here.

General settings:

4.4.1.2 Administration

EPOS Manager enables the possibility to create more admin users with different roles and privileges to manage this application.

Note: Only the administrator created on signup can create more admin users.

4.4.1.2.1 View Admins

The tab 'View Admins' is in the main view of the 'Manage Admin' layout, showing all the admins information.

The following details can be found in the view:

- Admin Name
- Role
- Email ID
- Contact
- Country
- Region
- Created On
- Created By

You can edit or permanently delete a specific admin from the database using the icon buttons available in the grid 'Action' column.

To create a new admin, click 'Add Admin' button available in the 'Manage Admin' layout and fill in the required information

Tenant Admin can generate Reset Password URL for sub admins from the View Admins Grid by clicking the Reset Password icon in the Action column for the sub admins. When clicked on this it will generate the reset password URL and show as pop up. Admin can share this link to the sub admin to reset the password.

4.4.1.2.2 Add/Edit Admin

To create new admin or update admin, following information is required:

- Admin First Name
- Admin Last Name
- Admin Email ID
- Admin Contact
- Region
- Country
- Time Zone
- Role

After filling in all the required details, click on 'Add' button to submit the details. Once details submitted successfully, Tenant Admin can use the Reset Password URL from View Admins Grid and share it to the sub admin to reset the password. 'Admin Email ID' is not editable in Edit Admin.

Three different roles are supported:

- Power User

(Provides full permissions for all the features except access to 'Administration' feature)

- Internal User

(Provides read-only permission for all the features except access to 'Administration' feature)

- Tenant Admin

(Logged-In Tenant details will be displayed in View-Admin grid and Delete action will be hidden for the same)

4.4.1.2.3 Transfer Ownership

To transfer the ownership to other admin, click on edit icon of admin to which you want to transfer the ownership, then click on 'Transfer Ownership' button.

4.4.1.3 Client config

A Tenant account specific Token (TenantConfiguration.dat) can be downloaded here, for deploying to end-user installations.

- 1. The token must be deployed to end-user machines when installing the EPOS Connect.
- 2. The token ensures that the clients are allowed to connect to the tenant-specific account on the EPOS Manager system.
- 3. The token is required for clients to be managed and to receive updates from the IT administrator.

The token (TenantConfiguration.dat) contains Tenant account specific information, ensuring a secure connection between the end-user application and the tenant-specific account.

Once downloaded, the TenantConfiguration.dat file is encrypted and cannot be read.

- 1. Backend Endpoint (server address of EPOS Manager API with which the EPOS Connect will communicate)
- Initial Heartbeat Time (The value set in "Heart Beat" indicates the duration in seconds after which the EPOS Connect will contact the server and check for available FW and SW updates).
- 3. Tenant specific ID

4.4.1.4 Change Password

The administrator can change the account password at any time. Go to the tenant dropdown menu and select "Change Password"

4.4.1.5 Help

Documentation and user guides for the system can be accessed by selecting "Help".

4.4.1.6 About

Select "About" to learn about system information.

The following system info will be shown:

- Version
- Build
- Date of the application

4.4.1.7 Logout

To secure account details and eliminate misuse of the system, select Logout after finishing tasks in the system

4.4.2 Grid settings

In Grid Settings, the listed column view can be arranged.

A user can customize the field columns by changing the following settings:

- Column properties
- Display selections
- Column display order

The changes made in the grid will be valid only for that specific machine and specific browser until that specific browser's application data is cleared.

4.4.2.1 Row count

"Number of rows" per page to be viewed can be set by clicking the dropdown button.

4.4.2.2 Display selections

Including, excluding and order of displayed fields can be set in the grid settings view.

Add to the Selected Column from the Available Column.

Remove from the Selected Column to the Available Column.

Add all fields to the Selected Column from the Available Column.

Remove all fields from the Selected Column to the Available Column.

4.4.2.3 Column display order

The column display order in the Selected Columns box determines the display order in the final view. Top to bottom order in the list box makes the change in reference to left to right order in the display. Once the column selection is highlighted in the Selected Columns, the column display order can be changed using the following functions.

Moves the selected column up in the list box (left in the final display).

Moves the selected column down in the list box (right in the final display).

To get the default settings, click "Restore Default Settings".

4.4.3 Search

Use the Search bar to quickly search for a specific attribute in the current view.

4.4.4 Information fields

The information field shows the result of the chosen main menu and associated tabs. The listed order can be sorted alphabetically and numerically in ascending or descending order.

To change the order of sorting, click on the field name to change the displayed order.

4.4.5 Page navigation

Navigating multiple pages in EPOS Manager is easily accessed at the bottom of the displayed view.

4.4.6 Application menu

The main menu contains associated selectable tabs, which will display subject specific information:

- Dashboard
- Manage Device
- Manage Updates
- Manage User
- Configuration
- Provision
- Meeting Rooms
- Reports

The selected menu will always be highlighted.

5. Dashboard

Dashboard gives the overall analysis of active devices, version updates, call Activity, Assets, and Deployments etc.

The dashboard contains the following categories

- Active Device
- Firmware Version
- Software Version
- Call Activity
- Your Assets
- Deployments



5.1 Active Device

This chart gives the information about the total count of active devices to the total number of devices. On click of Overview button, the site will navigate to the 'Device' tab of 'Reports', selecting 'Device Overview' from sub-category.

5.2 Firmware Version

This chart gives the information about the total count of firmware versions up to date to the total number of firmware versions available. On click of Overview button, the site will navigate to the 'Device' tab of 'Reports', selecting 'Update Overview' from sub-category.

5.3 Software Version

This chart gives the information about the total count of software versions up to date to the total number of software versions available. On click of Overview button, the site will navigate to the 'User' tab of 'Reports', selecting 'Client Versions' from sub-category.

5.4 Call Activity

Call Activity gives the total number of calls and Total call time. On click of Details button, the site will navigate to the 'Call Activity' tab of 'Reports', selecting 'Call Overview' from sub-category.

Note: Not Supported by EPOS Connect for VDI and thin clients.

5.5 Your Assets

Total Devices: This shows the total number of devices. On click of 'Total Devices' count, user is redirected to "All Devices" tab of "Manage Device" section.

5.5.1 Devices

This section contains the summary of Devices in a tabular view with the following columns.

- Device
- Type
- Percentage
- Quantity

5.5.2 Softphones

This section contains the summary of Softphones in a tabular view with the following columns.

- Softphone
- Type
- Percentage
- Quantity

Note: Not Supported by EPOS Connect for VDI and thin clients.

The total number of users, Users without devices, Total Admins count is shown at the bottom of the table. On Click of 'Total Users' count and 'Users without Device', user is redirected to "Users" tab of "Manage User". And on click of 'Total Admins', user is redirected to 'View Admins' tab of 'Manage Admin'.

5.6 Deployments

This section gives the deployment status of the updates and configurations. The following details are present in tabular view.

- Type: Download icon indicates update and settings icon indicates configuration
- Date
- Device
- Group
- Update Status

6. Manage user

Manage user menu is for managing users having the client application EPOS Connect installed on their local machine.

The user are automatically created in the system the first time the EPOS Connect is started on the end-user machine.

6.1 Users

For the user to be created in the system, the information FirstName, LastName and Email address needs to be available. This will happen automatically by the client querying the AD. If this information is not available or empty, the user will be created using the machine login name as username and email address as a combination of login name and domain name or id generated by the EPOS Connect client. Information such as Office, Country and City will also be queried. If no information is available the user information will stay blank.

The Administrator can manually add this information to the user if desired by clicking the edit icon on every user.

User have an option to export the data by clicking on the excel icon on the top right corner.

The users screen view will have the following details

- User
 - (User information is the combination of First Name and Last Name)
- E-mail
- Client Version
- Client Type
- Host Type
- No of Device(s)

(Will have the number of devices associated with the user)

- Last seen
- Current User Login
- Action

(Have options to edit or delete the user)

For much more information, Tenant or IT Admin can click on user name link to view Detail(s), Device(s) & Machine(s).

The Details tab view contains the following details

- First Name
- Last Name
- E-mail
- Client Version
- Client Type
- Last seen
- Country
- Office
- City
- Current User Login

The Devices tab view contains the following details

- Device Name
- FW Version
- Registered User
- Current User

(Gives info if the current user using that device)

- Last Seen

The Machines tab view contains the following details

- Machine Name
- Operating System
- OS Version
- Model
- System Type
- Processor Name
- Client Version
- Client Type

On expanding the 'Machine Name', details of the softphone installed in that machine will be displayed.

6.2 Manual group

When deploying a FW or SW update, this must be done to a group. (In case just one user is to receive an update, add the user to an empty group)

The Manual Group tab allows the tenant administrator to organize users into groups. In case a more detailed grouping of users is desired based on member criteria, sub-groups to an existing group can be created.

Example: A tenant administrator can choose to create groups for indicating departments, locations, floors, etc. having attached sub-groups containing members based on user/device profile.

For creating a new group or sub-group, click "Create New Group".

Select New Group from group type and fill in the group name and group description fields. For a sub-group, select new sub-group from group type and fill in the following details:

- Parent group
- Sub-group name
- Description

Add relevant users to a group by selecting users enrolled into the system and transfer to the group member list.

To quickly identify a specific user in the system, use the search bar located above the users list to search for the user to be added to the group.

To remove user(s) from a group, click the "x" icon in the action column inside the group member list.

Once group information and users have been added, click "Save" to save the created group.

Select all users checkbox can be used if all users are to be registered in the system to receive the updates, including users added in the future. Enabling this checkbox will overrule any other selections made and will disable the grids for manual selection.

In the manual group list, a "+" sign next to a group name indicates that the group contains sub-groups. Click the "+" sign to expand the structure to view the sub-groups connected.

Clicking "-" next to an expanded group structure will collapse the group view.

You can edit, hide or permanently delete a specific group. To edit the parameters for a group or sub-group, click the edit icon.

When a change to group parameters has been performed, click "Save" to apply changes.

6.3 AD group

The AD Group tab allows the tenant administrator to create, view and edit user groups reflecting the Active Directory (AD) distribution lists used in their organization.

The AD Group created in EPOS Manager can be used by EPOS Connect to determine if the end-user belongs to the Active Directory distribution list or not and make the update or configuration available.

The following details can be viewed:

- AD group name
- Creator
- Date and time

You can edit, hide or permanently delete a specific AD group.

To create a new AD group, select the Create AD Group button. Fill in the AD Group Name (reference name in EPOS Manager and should start with the syntax AD_*) and AD Search String. Click Add to create the new AD group.

Note: As an example, the below stated information is required to be filled in the "Create AD Group" window to create an AD Group.

AD Group Name: AD_GroupIdentifier

AD Search String: LDAP://LocalDomain/CN=GroupIdentifier,OU=Group,OU=Department, OU=Organization,OU=Operating region,DC=Root domain,DC=com (AD search string for the distribution list. You can use the Windows Tool ADExplorer to identify the AD search string to be used.)

Where

CN = Common name

OU = Organizational unit Name

DC = Domain component.

To edit an AD Group, click the AD Group Name and AD Search String.

Click "Save" to apply the changes.

Note: It is not possible to edit an AD Group if there are active deployments using the group. It is required to stop deployments, edit and then resend the deployment.

Note: EPOS Connect for MAC and EPOS Connect for VDI and thin clients do not support AD Groups.

6.4 Inactive users

It helps to manage the inactive users in the system for a certain span of time period and an option is provided to filter inactive users based on different time period.

Following are the different time periods:

- 1 Month
- 3 Months (Default)
- 6 Months
- 1 Year

User have an option to export the data by clicking on the excel icon on the top right corner Delete option is provided in the layout to delete the users.

6.5 Deleted users

Users deleted from the "Manage User" list will be placed under the "Deleted User" tab.

A tenant administrator can choose to either permanently delete a user from the system, or to restore the user.

If a user resides in the "**Deleted users**" list, the EPOS Connect client belonging to the user will no longer be able to receive updates.

If a user is permanently removed from the "**Deleted Users**" tab, all user specific information and historical data about usage is deleted.

User have an option to export the data by clicking on the excel icon on the top right corner

Select the "Restore User" button to move the user from the deleted users tab list to the Users tab list and the user will be able to receive updates again.

Select the "Delete User" button to permanently delete the user from the system.

7. Manage device

The Manage Device menu is for managing the assets deployed in the organization.

You can view the details by clicking on the particular asset.

7.1 All Devices

The tab "All Devices" is the main view, shows all EPOS devices.

The following details can be found in the view:

- Device Name
- Meeting Room
- Vendor
- Type
- Device ID
- FW Version (update available icon/release notes is shown when a new update is available)
- Current User
- Last Seen
- Host Name

For even more detailed information about a device, click on the device name and find the following information about the device.

- Device name
- Status of device
- Type
- Device ID
- Firmware Version (update available icon/release notes is shown when a new update is available)
- First seen
- Last used date
- Last user
- Meeting Room (link will navigate to the meeting room view page.)
- Country
- Office
- City
- First Contact FW Version
- First Contact IP Address
- Last Contact IP Addres
- Current User Login
- Current User Email

The "Configuration" tab in the details page shows list of configuration/settings.

The "ConnectedTo" tab in the details page shows which products are connected to each other with an easy way to navigate between the products by clicking the hyperlink of the product in the connected to list.

Note:

- 1. Configuration tab will display only if there is any configuration settings avilable for that device.
- 2. ConnectedTo tab will display only if device is connected to other device.

To Remove Device, select device and click on the "Remove" button, once we click on that a pop-up information appears and the following details will be displayed:

- Status (shows that device is Active or Inactive)
- Device Name
- Device ID
- Vendor
- Description (used to add the reason to remove device)

The removed device can be viewed by clicking the tab "Removed Devices".

Note: Remove button functionality works same in "Devices In Use" and "Inactive Devices" tab.

To change the meeting room, select the devices in the adjacent box of the same row and click on 'Change Meeting Room' button. Select meeting room from dropdown and click the Save button. To remove the meeting room, select the devices in the adjacent box of the same row and click on 'Change Meeting Room' button. Remove the meeting room and click the Save button.

Note: If you associate a device to a meeting room which is already associated to another meeting room, then that device will be disassociated from previous meeting room. One device can associate to one meeting room at a time.

'Device Type' filter is added with a multiselect option and supports the following device types filter

- Wireless DECT
- Wired USB
- Wireless BT
- Speakerphone
- Video

By default, 'All' will be applied.

7.2 Devices in Use

Devices in Use tab shows the details of devices which are in use.

The view includes the following details:

- Device Name
- Meeting Room
- Vendor
- Type
- Device Id
- FW Version
- Current User
- Last Seen
- Host Name

A device can be removed by selecting it from the "Devices in use" list.

7.3 Inactive Devices

It helps to manage the inactive devices in the system for a certain span of time period and an option is provided to filter inactive devices based on different time period.

The view includes the following details:

- Device Name
- Meeting Room
- Vendor
- Type
- Device ID
- FW Version
- Current User
- Last Seen Host Name

Following are the different time periods:

- 1 Month
- 3 Months (Default)
- 6 Months
- 1 Year

A inactive device can be removed by selecting it from the "Inactive devices" list.

7.4 Removed Device

It shows details of all the removed devices.

Devices taken out for maintenance, or discarded can be removed from the system by using the "Removed devices" tab.

Once a device is removed from the "All Devices", "Devices In Use" and "Inactive Devices" tab, device will be moved to the "Removed devices" tab.

The view includes the following details:

- Device Name
- Meeting Room
- Device ID
- Firmware Version
- Current User
- Type of the device
- Last used time and date
- Reason for removal Host Name

Select a device which you would like to delete and then click on the "Delete Device" button.

8. Manage updates

The "Manage Updates" menu can be used for managing software updates of application and firmware updates of the assets (headsets) deployed in the organization. You can choose to schedule updates to take place at specific time of the day. You can choose to deploy a "Mandatory" update to a device, to ensure that an important update of that device will be performed mandatorily.

You can choose to deploy a "Silent" update to a device, to ensure that an update happens silently, without any user interaction or when the user is logged off from the machine, in the defined Update Window. Silent update is only applicable for firmware updates. After the end date, the "Silent Update" will behave as a mandatory update for the end user.

Note: Silent update is not supported if the machine is in sleep mode or turned off.

You can select the type of update from the drop down menu.

- You can choose specific user group for the update by clicking on the drop down menu and selecting the boxes adjacent to the desired user group. "Select all" will select all the user groups. "Deselect all" will clear all the selections in the list. To ease the selection, type the name of the user group in the search box and perform the desired action.
- For scheduling date and time, click in the box and select date and time as required.
- To select date, click on the specific day in the month of the year.

To return to the date selection, click the calendar button.

- It is possible to download the software or a firmware locally by clicking the download icon.
- To discard any version of the software or firmware, click on the reject button.

8.1 Firmware updates

Under the tab "Firmware Updates" new device-specific firmware releases from EPOS will be available for deployment in the organization.

To benefit from device firmware improvements and enhanced functionality released via updates from EPOS, it is highly recommended to keep devices in the organization updated.

User can filter the data using the versions and devices dropdowns.

Versions dropdown has two options

- Show Latest: gives the highest Firmware version list.
- Show All: will display all the records

Devices dropdown has two options.

- Show All: will display all firmware version list.
- Connected: will display firmware list related to connected devices.

The following details about the release can be viewed:

- Device name of the device to be upgraded
- Type of the device which can be firmware
- Latest version of the firmware in the device
- Release notes by clicking on the associated icon
- Date and time of receiving the update notification

- Source from where the update is sent
- Type of build which can be Beta or Production.

From the column "Action" you can deploy, download or delete the software released from EPOS.

Deploy multiple Firmware updates to multiple user groups by selecting the check box(s) against each Firmware and then click on the Deploy button which is above the grid and next to versions.

To promote a "BETA build to Production", click on the promote build icon next to beta then the build will be changed from beta to production.

8.2 Software updates

Under the tab "Software Update" new versions of the end-user software "EPOS Connect" will be available for deployment in your organization.

User can filter the data using the versions dropdown which has two options.

- Show Latest: gives the highest Software version list.
- Show All: will display all the records

The following details can be viewed:

- Release notes
- Date and time of receiving the update notification.
- Source from where the update has been sent.

From the column "Action," you can deploy, download or delete the software released from EPOS. EPOS Connect for Win latest version supports msi installer and can be downloaded.

Deploy multiple Software updates to multiple user groups by selecting the check box(s) against each Software and then click on the Deploy button which is above the grid and next to versions.

Note: When deploying a software update of the client a warning will be presented.

This is because the EPOS Connect software requires administrative rights for installation. This has the following impact.

For users without administrative rights on their machine, they will be prompted to enter user credentials and password for a user with the right permissions.

For user with administrative rights the user can still be prompted with a "Do you want allow the following program to make changes to this computer" message box. This is default windows behaviour caused by the UAC settings. This can be removed by changing the UAC settings to never notify, but this is not recommended. The user has to click yes for the software to install.

The recommended way of updating the software is to use a mass deployment tool such as SCCM / Jamf Pro.

To promote a "BETA build to Production", click on the promote build icon next to beta then the build will be changed from beta to production.

8.3 Upload updates

EPOS will be sending out notifications whenever there is a new firmware or software release to the Tenant Admin who has signed up for EPOS Manager.

IT admin can download the update from the cloud server and upload it to local EPOS Manager so that they are available to be deployed with in the organization.

The Administrator can select radio button for either software or firmware update.

Note: The following three priorities can be selected by the administrator.

- Critical Update
- Recommended Update
- Minor Update

For software or firmware update select the priority .Click in the box to browse or drag the file in the box to attach the file. Select Upload to deploy it later.

8.4 Deployment Status

All active deployment jobs are listed in this view.

The following information is presented here:

- Job Created: Time stamp the job was created.
- Type: The job type. (Currently only Update)
- Device: The device, software targeted with this job.
- Group name: The name of the group the update is sent to.
- Version: Version of the software, firmware that was deployed.
- Devices Reached: KPI of the distribution.
- Update success: KPI of update being completed.
- The "Device Reached" KPI represents:

Gray

Color as status is not yet available

- It is a background job, it collects the KPI status and display one of the below status after some time interval.

Green Color as download success.

Red

Color as download not yet done.

On hovering over the color bar, it shows the number of devices for which the firmware download was a success or not yet downloaded.

The "Upgrade Status" KPI represents:

Gray

Color as status is not yet available

- It is a background job, it collects the KPI status and display one of the below status after some time interval.

Green Color as upgrade success

Red color as upgrade failed

Orange Orange color as upgrade pending.

When clicking the color bar or device link will bring you to the details page.

Note: The KPI information is only rendered after 60 minutes and will therefore only be available thereafter.

8.5 Deployment details

The deployment details page gives you more specific information of the actual status.

- Scheduled Time: The schedule time that was given when deployed.
- Update: The name of the device or software and its new version.
- Deploy Group: The name of the group the update is sent to.
- Devices Reached: KPI of the distribution.
- Update success rate: KPI of update being completed.
- Deploy Type: Update type deployed to end-users Mandatory/Optional/Silent
- Deployment Start Date: The date from when Silent update is applicable.
- Deployment End Date: The date when Silent update period ends.
- Update Window: Updates will be applied only during this time interval

The "Device reached " KPI represents:

Gray Color as sta

Color as status is not yet available

- It is a background job, it collects the KPI status and display one of the below status after some time interval.

Green Color as download success.

Red Color as download not yet done.

On hovering over the color bar, it shows the number of devices for which the firmware download was a success or not yet downloaded.

The "Upgrade Status" KPI represents:

Green Color as upgrade success

Red Color as upgrade failed

Orange Color as upgrade pending.

"Update Success" tab displays the devices for which deployment succeeded.

"Update failure" tab displays the devices for which deployment failed. (Update was downloaded and the update attempt was done)

"Update pending" tab displays the devices for which update is pending. Download had been done but update has not yet started.)

Device not Reached tab displays the devices which have not yet downloaded the update.

9. Configuration

EPOS Manager enables the possibility to read the settings of the connected devices and softphone settings of EPOS Connect.

Using the tool, a user is able to push configurations and lock specific settings on the end users devices by pushing a configuration package.

In the current example we will be pushing a regulatory compliance setting to a group. The flow is very similar to a firmware update so the prerequisites are the same.

Before the configuration please ensure that the devices are updated with the latest firmware update.

9.1 Configuration Overview

The configuration overview page is designed to act as a dashboard to view and easily compare configuration settings. The page lists all devices that are applicable for a configuration and gather all the settings in one place.

In Configuration overview layout, implemented 'Device Type' filter and currently this filter supports to filter on below device types

- Wireless DECT
- Wired USB
- Wireless BT
- Speakerphone
- EPOS Connect
- Video

By default, 'Wireless DECT' filter will be applied

In this view all configurable devices are listed and you can do a global search to filter on either devices, users or deployed configuration package.

The deployed pack column shows if and what configuration package has been pushed to the specific device.

The version column gives the information about the release versions of the uploaded pack. Shows the number of configuration parameters available on the product. Clicking it will open up a view of all the configurations and their value on the product.

If the number shows 0 it means that the device does not support any configuration. Most likely because the firmware version is not supporting it. Suggestion is to update to latest firmware.

Configuration ▼

For comparing a single value, it is possible to click the drop down on the title bar to select 1 of the available configurations. The grid now changes to only show the selected configuration and value. This provides an easy way to compare many devices quickly just by viewing them.

9.2 Device Repository

The Device Repository TAB contains a list of all raw device packages uploaded. These packages will be read only when uploaded and all values will be empty.

User can filter the data using the versions and devices dropdowns.

Versions dropdown has two options

- Show Latest: Will show highest version followed by the latest timestamp of the received On / Uploaded On column.
- Show All: will display all the records.

Devices dropdown has two options.

- Show All: will display all device packages.
- Connected: will display packages related to connected devices.

9.2.1 Duplicate configuration package For editing the package and choosing the values of the configuration it is required to

create a copy of the package. This is done by clicking the "Copy" icon on the line, providing a new pack name and clicking "Save".

A new package is then added and an "Edit" icon is shown on the line.

9.2.2 Edit configuration package

Once the package is duplicated, it is now editable and a small edit icon will appear.

Configuration repository screenshot highlighting edit icon

Package can now be duplicated again, deployed, edited or deleted.

Clicking the edit button opens the package to allow setting the values.

The values can be selected by opening the drop down. When a selection has been made a graphical representation is shown for the device MMI where available. When selecting a value and deploying it, the given value will be locked on the end user device and the user will not be able to change the value themselves, not even by changing the physical switch. To release the setting again (to enable the user to alter the settings), the blank value needs to be chosen and the package needs to be redeployed.

The settings can be saved by clicking the **"Save"** button.

9.2.3 Deploying Configuration

Once the package is ready, it can be deployed to a user group. This is done by clicking the **"Deploy"** icon.

A user group needs to be selected to deploy a package. To send the package click the "Deploy" Now button. The configuration will happen silently on the end user device on the next heartbeat.

Deploy multiple Device configurations to multiple user groups by selecting the check box(s) against each Device configuration and then click on the Deploy button which is above the grid and next to versions.

9.3 Software repository

The Software Configuration TAB contains a list of all raw EPOS Connect softphone configuration packages uploaded. These packages will be read only when uploaded and all values will be empty.

User can filter the data using the versions dropdown which has two options.

- Show Latest: Will show the highest version followed by the latest timestamp of the received On / Uploaded On column.
- Show All: will display all the records

All grid action use cases like duplicating, editing and deploying the packages are similar to the 'Device Repository' TAB grid action use cases. (Referring to the section 9.2.1 to 9.2.3)

9.4 Upload Configuration

EPOS will be sending out notifications whenever there is a configuration update to the Tenant Admin who has signed up for EPOS Manager.

IT admin can download the configuration from the cloud server and upload it to local EPOS Manager so that they are available to be deployed within the organization

The Tenant Administrator can then upload a configuration package as a zip file and the package will be uploaded.

9.5 Deployment Status

Very similar to the firmware deployment, it is possible to follow the status of the configuration package deployment (Referring to the section 8.4).

10. Provision

The provision menu is used for provisioning of smart devices with the IT Admin preferred settings using Quick Connect Codes. You can view the details of Quick Connect Code and Create/Edit Quick Connect Code.

10.1 Quick Connect Codes

The following details can be found in the view:

- Code
- Communication App
- Quick Connect Name
- Active
- Devices Used
- Devices Allowed
- Expiry Date
- Date Created

You can edit or permanently delete a specific Quick Connect Code using the icon buttons available in the 'Action' column.

You can even copy QR Code using the copy icon in the 'Action' column.

'Active' column in the grid states whether the Quick Connect Code is active or not and can be used to provision devices.

To update Quick Connect Code click on 'Code' in the grid or edit icon.

To create a new Quick Connect Code, click on 'Create Quick Connect Code' button available in 'Quick Connect Codes' layout and fill the required information.

10.2 Create/Edit Quick Connect Code

To create the new Quick Connect Code, the following information is required.

- Quick Connect Name
- Expiry Date
- Number of Devices Allowed
- Select Models
- Communication App
- Language
- Timezone

After filling the required details click on Create button to create the Quick Connect Code and stays in the same page with details filled and QR code generated.

Cancel button redirects to previous page (to list of Quick Connect Codes).

Users can download QR Code (downloads.png) or Copy QR code.

11. Meeting Rooms

Tenant admins can create meeting room(s) and associate their devices to the meeting room. You can View/Edit/Remove the details of a meeting room.

The following details can be found in the view:

- Meeting Room Name
- Devices Attached Expand to view the Device Name, FWVersion (update available icon/release notes is shown when a new update is available)
- FW Update Available

Sorting is provided on "Meeting Room Name" column and default records will be in ascending alphabet order of "Meeting Room Name".

Manage Device --> Device details page can be used to associate/disassociate a device to a meeting room.

You can view the associated devices to a particular meeting room in the View Meeting Room page. You can edit or remove a specific Meeting Room using the icon buttons available in the 'Action' column.

11.1 Create Meeting Room

To create a new Meeting Room, click on 'Create Meeting Room' button from 'Meeting Rooms' view page and provide a name for the meeting room and click on Create button.

11.2 View Meeting Room

To see the details of devices attached to a meeting room, click on meeting room name in Meeting Rooms grid view.

The following details can be found in the 'View Meeting Room':

- Status (Active/Inactive)
- Device Name
- Device ID
- FW Version (update available icon/release notes is shown when a new update is available)
- Action

You can navigate to the Manage Device page by using the Manage Device link and associate/disassociate a device. You can remove the device by clicking on Remove option available under 'Action' column.

User will navigate to device detail page on click of "Device Name" in meeting room view page. User can see the FW version, Release notes under FW Version column if any update is available.

12. Reports

Reports offer an in-depth analysis of the existing device conditions in an organization.

The reports have two sub-menus showing the details of the following:

- User
- Device
- Call activity
- Softphone

A chart being viewed can be downloaded or printed by clicking the icon shown at the right top corner of the chart's interactive region.

To select the desired output format, click the icon and select the relevant option.

The below stated options are available to the tenant:

- 1. PNG image
- 2. JPEG image
- 3. PDF document
- 4. SVG vector image

Click the legends to show or hide the values in the existing chart.

An active user for a monthly statistics is defined as:

"Someone who has used the EPOS Connect at least once during the month"

An active user for daily statistics is defined as:

"Someone who has used the EPOS Connect at least once during the day"

Note: All the data for the reports is with reference to the Greenwich Mean Time (GMT).

12.1 User

The total number of active and inactive users will display an index with a standard goal and help to identify inactive devices. A status summary of deployed EPOS Connect client software compared to available versions is also available.

12.1.1 User Overview

"User overview" will show the daily statistics summary of the total number of active users in a week.

The pointer can be placed over any section of the day column for the exact key values.

12.1.2 Client versions

The Client share pie chart will show the share of EPOS Connect variants.

The Client version share pie chart shows the version of the EPOS Connect being used based on the Client Type filter selected.

12.1.3 Monthly Overview

The overview will show the monthly statistics summary of the total number of users and active users in a year. To view the exact numeric value, position the pointer over any section. This graph can be used to verify that the installations correspond to the number of users/employees.

12.2 Device

Evaluating the statistics of the devices used by the end-user reflects the device usage in an organization.

The device menu also provides an overview of the competitor products (including distribution) in the organization.

12.2.1 Device Overview

An overview shows a clear synopsis of the total number of devices (active/inactive) with the following active devices of the series.

The following active vs. inactive devices under series are shown in the chart.

Wired ED headsets (analog headsets)

Wireless DECT headsets

Wireless BT headsets (Bluetooth products)

Wired USB headsets

Speakerphones

Video

There are different types of devices used by the end-users. "Device overview" help to find out the usability index of the active devices on a daily basis.

- Wired ED headsets (analog headsets)
- Wireless DECT headsets
- Wireless BT headsets (Bluetooth products)
- Wired USB headsets

The trend of the active devices can be seen on a weekly basis.

12.2.2 Other devices

Click on a segment to explode that segment for a better understanding of the comparison.

12.2.3 Device adoption

An overview shows a clear synopsis of the total number of devices (active/inactive) with the following active devices of the series.

The following active vs. inactive devices under series are shown in the chart.

- Wired ED headsets (analog headsets)
- Wireless DECT headsets
- Wireless BT headsets (Bluetooth products)
- Wired USB headsets
- Speakerphones
- Video

The chart identifies the number of devices that have not been connected in three different time ranges. The following selections are available:

Monthly: the chart shows a full calendar month.

Half yearly: the chart shows six calendar months.

Yearly: the chart shows a full calendar year.

We can switch to a detailed view by clicking on any of the device family types.

12.2.4 Headsets per User

This report overview shows the user count based on the number of headsets being used.

12.2.5 Update Overview

The overview will show the percentage of the devices which are having the latest version to the ones which are yet to be updated. The firmware version approved by the tenant is taken as reference to calculate the percentage.

When clicking the report, the user can view the detailed report for each device model which shows the count of the devices with different firmware version currently used.

12.3 Call Activity

Evaluating the statistics of the call activity of the end-user reflects the call activity statistics by the company.

The Call activity menu does an analysis based on the call type and call duration of softphones and devices.

Note: Not Supported by EPOS Connect for VDI and thin clients.

12.3.1 Call Overview

Call overview gives the analysis about the number of incoming and outgoing calls attended during the specified period.

Following are the different time period filters can be applied on the chart

- Last week: the chart shows the number of calls attended daily basis for the last seven days
- Last Month: the chart shows number of calls attended daily basis for the last month i.e.
 last thirty days.
- Monthly: the chart shows the number of calls attended monthly basis for the last one year
- Half Yearly: the chart shows the number of calls attended half yearly basis for the last one year
- Yearly: the chart shows the number of calls attended yearly basis for last one year

By clicking on a specific series/bar in the chart, more details of the call for the corresponding time period will be displayed in the table view.

SOFTPHONE BRAND SHARE: This report gives the information about percentage of total softphones of different brands.
